Permission has been granted by the Barn Hunt Association, LLC for the holding of these barn hunt trials under BHA Rules and Regulations.

Three Rings and three judges. Open to all Breeds and Mixed Breeds of all sizes!

Classes offered on Saturday and Sunday: Instinct Test, Novice, Open, Senior, Master Crazy 8s (limit 25 runs) offered on Sunday only!

On both there will be a short lunch break at the judges' discretion. Move ups will be allowed between trials. Remember if your dog has passed the Novice title you cannot enter Instinct.

Judges:

Teal Erickson (BHAJ-132A), Barbara Gibson (BHAJ-065A) Jennifer Riess, (BHAJ-001A) – any judge of record may help judging in any ring at these trials.

Entries will be accepted on a first received basis, opening January 18 2017. If limits are not reached by closing we will accept DOS entries $\frac{1}{2}$ hr before the start time of each trial.

Entry fees are \$15 for Instinct, \$20 for Crazy 8s, and all Regular Classes except Master. Master is \$25. Day of Show Entries are \$25 for Regular Classes, \$30 for Master and \$20 for Instinct Test.

EXHIBITOR INFORMATION

Dogs may enter both the Instinct Test and Novice class in the same trial *until the dog has earned the RATN title and then they cannot enter the Instinct Test.* Dogs completing the RATN in the morning trial either day may be moved up to Open for the second trial. This is up to the handler and not required. Move-ups will be accepted up until ½ hour after the conclusion of Trial 1 each day. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. Make check payable to GTA. Send entries & fees to the trial secretary. Dogs must have a Barn Hunt registration number. Refunds will be made in full if a dog is pulled before the March 12 pre-entry closing date but not after except for a veterinary excuse.

You can auto generate entry forms from the Barn Hunt website. <u>www.barnhunt.com</u>. Log into the register, select the trial you want to enter and follow the instructions. Make sure to print and sign your entry form.

Directions to Test Site

From Interstate I-44 East or West: take Exit 253, Gray Summit. Take Hwy 100 E. Follow for ~0.4 mile to Hwy MM. Turn Left onto MM. Follow ~ 2 miles; Purina Farms, Checkerboard Dr will be on the left.

All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS.** There is **NO SMOKING** in this facility or on the grounds. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

AWARDS: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. Ribbons will be awarded for first through fourth place in Novice through Master. High in Class ribbons and new title ribbons will be awarded.

These trials will be indoors at Gateway Hall and there will be indoor crating space available. Please make sure your crate is secure as the dogs may be highly excited. There are indoor restrooms at the site. Gateway Hall has areas close to the building where they do not want you to potty your dogs, so please follow instructions and please pick up after you dog(s).

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

There is a lunch concession on site and a prohibition of outdoor food/drink. Lunch will be provided for volunteers

Masters classes will be run with blinds of 3 or 4 dogs.
